

# 2018 Workplace Giving Excellence Awards

## CONDITIONS OF ENTRY

Nominations must be received by the Awards Secretariat (Workplace Giving Australia (WGA)) by 24 August 2018, 5pm Australian Eastern Standard Time.

Nominations must be submitted via the online application forms on [www.1MDonors.org.au](http://www.1MDonors.org.au).

Applications must receive sign-off from key stakeholders within the nominated organisation. It is strongly recommend that in instances where a partner or supporting organisation is mentioned within an application that they also sign-off on the entry.

There is **no limit to the number of categories** applicants may enter, provided they meet the eligibility criteria for each.

Organisations **may only submit one entry per category, with the exception of "Most Innovative Charity / Employer Partnership"** where there is no limit to the number of employer partnerships the charity applicant can nominate (note that each employer partnership must be submitted as a separate entry).

All information and data relating to applications must be based on the time frames specified for each category, a summary of which is below:

### 12-months prior to submission

- Best Overall Program
- Best Public Sector Program
- Best Pro-Bono / Workplace Volunteering
- Most Innovative Charity / Employer Partnership
- Most Unique Innovation

### 18-month prior to submission

- Best Launch / Refresh (Employer)
- Best Launch / Refresh (Charity)

Organisations may only submit a launch / refresh campaign into the "Best Launch / Refresh Award" (Employer or Charity categories) once. Applicants will need to decide which Awards within the 18-month timeframe is the optimum one to enter.

### Public Ancillary Funds (PAFs)

In instances where a PAF is a vehicle for managing one company's community investment, and only receives charitable donations from that one company and/or its employees, for the purposes of these Awards it will be considered to be a part of that company and should enter Awards open to 'Employers'. In instances where a PAF accepts donations from more than one employer organisation, for the purposes of these Awards it will be considered to be an independent entity and should enter the Awards open to 'Charities'.

Shortlisted finalists may be required to produce proof or further details to support their application/s.

All judges' decisions are final and no correspondence will be entered into relating to the judging process or the outcome.

Judges reserve the right to determine whether an entry qualifies as acceptable. Entries the judges deem unacceptable will be ruled invalid. If an entry does not comply with these conditions, it will be ruled invalid and withdrawn from consideration.

These conditions may be amended at the discretion of WGA.
